

**NOTICE TO ELECTORS OF CLOSE
OF REGISTRATION FOR THE
MUNICIPAL GENERAL ELECTION
TO BE HELD ON TUESDAY, JUNE 15, 2021
IN BOULDER CITY, NEVADA**

NOTICE IS HEREBY GIVEN for registration of qualified electors for the Municipal General Election to be held on June 15, 2021.

Any qualified elector whose name does not appear on the official registry list may apply for registration by mail or online in the manner approved by law according to the deadlines listed below.

The deadlines to update your existing voter registration by mail or online in time for the June 15, 2021, Municipal General Election and still receive a regular mail ballot are below. After those dates pass, voters who wish to make changes to their registration information will have to do so through the same-day updates process, either online or in-person, and they may only vote a paper provisional ballot in-person at any early voting site or on Election Day at any Vote Center.

Nevada and federal law require first-time registrants to provide an identifying number (Nevada driver's license number or the last four digits of their social security number). If these do not match the records maintained by the Department of Motor Vehicles or Social Security Administration, the registrant will be required to present identification before being allowed to vote. Forms of current and valid identification include a Nevada Driver's License, Nevada I.D. Card, military identification card, OR a copy of a current utility bill, bank statement, paycheck, or document issued by a government entity, listing the registrant's name, and residential address.

UPDATING YOUR EXISTING REGISTRATION

Online Updates: If you could not register or update your existing voter registration by mail by May 18, 2021, you may update it or register through the Secretary of State's website at www.registertovotenv.gov through June 1, 2021 (Tuesday).

- **May 19 to June 1:** If you register or update your registration online between May 19 (Wednesday) and June 1 (Tuesday), you will receive a regular mail ballot.
- **June 2 to June 10:** If you register or update your registration online between June 2 (Wednesday) and June 10 (Thursday), you may only vote a provisional ballot in person at any early voting site or Election Day vote center. New registrants must show current and valid Nevada DMV ID at the voting site.
- **June 3 to June 11, and June 15, 2021:** You may register to vote or update your existing registration *in-person* at any early voting site or Election Day vote center, but for the current election you may only vote a provisional ballot. New registrants must show current and valid Nevada DMV ID at the voting site.

A provisional ballot will have all the contests and candidates that are on a regular ballot. It will differ from a regular ballot in that it will be counted only after verification that: (a) You were qualified to cast a ballot in the current election; (b) You did not cast multiple ballots in the same election; (c) You showed acceptable identification when you voted; and (d) If needed, you provided acceptable proof of residency.
