4-4-1: SCOPE:

A. It shall be unlawful for any person to allow, operate, carry on, conduct or maintain gambling within the city, except as hereinafter provided. The playing of social games in private homes or residences is permitted.

B. As set forth in section 128.3, Boulder City charter, as amended May 2, 1967, a bona fide religious, nonprofit, charitable or other similar corporation may be issued a special event permit, in accordance with procedures hereinafter provided, to conduct gambling on a limited basis to raise funds for the purpose of financing activities for which such organization is founded. (Ord. 1513, 9-24-2013, eff. 10-17-2013)

4-4-2: DEFINITIONS:

BOULDER CITY LICENSE BOARD: Shall consist of the city attorney, the city manager and the city clerk, or their designated representatives. The city manager shall designate a secretary to the license board. The finance director or his designated representative shall serve as license officer to the license board.

GAMBLING: Defined and limited to the following social games, such as: raffles, bingo, bridge, canasta, pinochle.

QUALIFIED CORPORATIONS: A bona fide charitable, civic, educational, fraternal, patriotic, political, religious or veterans' organization that is not operated for profit, and has applied for and been approved for a nonprofit permit.

RAFFLE: Any scheme for the disposal or distribution of property, by chance, among persons who have paid or promised to pay any valuable consideration for the chance of obtaining that property, or a portion of it, or for any share or interest in that property upon any agreement, understanding or expectation that it is to be distributed or disposed of by lot or chance.

SPECIAL EVENT PERMIT: A permit issued for the purpose of conducting activities on a limited basis to raise funds for the purpose of financing activities for which such organization is founded. (Ord. 1513, 9-24-2013, eff. 10-17-2013)

4-4-3: APPLICATION FOR SPECIAL EVENT PERMIT:

Every application for a special event permit for gambling shall be made to the license board on application forms to be provided by the license officer. Each application shall state the type of gambling, the length of time requested, where the activity will be conducted, who will participate in the gambling, and the purpose of the fundraising activity.

A. Number Limited: Permit for special events proposed for participation by the general public, as well as members of the corporation, shall be limited as follows:

1. Each special event, except raffles, shall be limited to not more than two (2) events per calendar year for each corporation, and each shall be for a period of time not to exceed a seventy two (72) hour period.
2. Two (2) raffles, or similar gambling events for each corporation, may be held per calendar year.

B. Calendar Year Permits: Permit for special events proposed for participation only by members of the corporation and to guests of those members while attending special events sponsored by the organization, may be issued for a calendar year, providing an application is filed and approved by the license board for the list of corporations authorized to conduct such fundraising activities. 4-4-4: PERMIT FEES:

Each application for a special event permit, whether proposed for general public participation or for participation by members only, shall be accompanied by a permit fee, which shall be set by resolution of the city council. (Ord. 1513, 9-24-2013, eff. 10-17-2013)

4-4-5: APPROVAL OR DENIAL:

A. Processing Time Limit: Each application shall be processed by the license board within fifteen (15) business days of the date in which it is filed.

B. Transferability: Any permit issued under the provisions of this chapter shall not be transferable to any other organization.

C. Review Procedure: Procedure for review of special event permit:

1. Determination Of Application: The license board shall make its determination as to whether the application shall be granted or denied. Such determination shall include such terms and conditions as the license board deems proper under the circumstances.
 - a. Any application for special event permit recommended for denial by an affirmative vote of any two (2) members of the license board shall not be granted, unless the denial is appealed and the city council votes in favor of said application.
2. Calendar Year Permits: The license board shall have the authority to approve said permit application, deny the said permit application, or approve it with such terms and conditions as may seem to be proper under the circumstances. (Ord. 1513, 9-24-2013, eff. 10-17-2013)

4-4-6: REVOCATION OF PERMIT:

A. Authority: The license board shall have the right to revoke permits granted under this chapter on such terms and conditions as may seem fit and proper to said board for the purpose of protecting the public health, safety and welfare of the city.

B. Emergency Exercise Of Police Power: The chief of police shall have the authority as an emergency exercise of the police power to revoke any special event permit if the gambling activities are being conducted in a manner which adversely effects the public peace, safety or welfare of the city. (Ord. 1513, 9-24-2013, eff. 10-17-2013)

4-4-7: RIGHTS OF APPEAL:

Any order, requirement, decision, determination, interpretation or ruling made by the license board, as applicable in the administration or enforcement of the provisions of this chapter, may be appealed therefrom to the city council.

A. Notice: Notice of appeal shall be in writing and shall be filed in the office of the city clerk, who shall include the appeal on the agenda for the next regular or special meetings of the city council, whichever occurs first.

B. Filing Time Limit: An appeal shall be filed within five (5) days after receipt of notice from the license board.

C. Consideration: The city council shall consider the appeal and such additional evidence as may be offered, and may affirm, reverse or modify in whole or in part the order, requirement, decision, determination, interpretation or ruling appealed from, or make and substitute such other or additional decisions as it may find warranted under the provisions of this chapter. The decision of the city council on such matters shall be final. (Ord. 1513, 9-24-2013, eff. 10-17-2013)
